

Doing Business with the San Diego Community College District



An Invitation to Contractors

The San Diego Community College District (SDCCD) invites licensed contractors to submit information to be included on the District's list of qualified bidders for projects bid under the California Uniform Public Construction Cost Accounting Act (CUPCCAA).

The SDCCD develops and maintains a list of contractors qualified to perform work on behalf of the District, in accordance with public contract code requirements.

Qualified contractors from this list are solicited on informal bids for the district's public works projects valued between \$45,000 and \$175,000. Solicitations go to contractors on this list first. If there are no contractors on the list who have the required license, then the solicitation will be sent to trade journals or other contractor publications. Contractors interested in being added to the list of qualified bidders should complete and return the Contractor Registration Application on the next page.

WHAT IS CUPCCAA?

The California Uniform Public Construction Cost Accounting Act (CUPCCAA) is under the umbrella of the California Uniform Public Construction Cost Accounting Commission (CUPCCAC), and provides for alternative bidding procedures when an agency performs public project work by contract, and in accordance with Section 22032 of the state's Public Contract Code.

1. Public projects of \$45,000 or less may be performed by negotiated contract.
2. Public projects of \$175,000 or less may be let to contract by the informal procedures set forth in the Act.
3. Public projects of more than \$175,000 shall be let to contract by formal bidding procedures.

5. Type of work the contractor is licensed to perform
6. The contractor’s license class and number
7. The contractors Department of Industrial Relations (DIR) number
